This is to help with the duplication of merchandise. The exact menu and price list you send will be the one you are required to use during our event. No price changes or slashing or additions to your menu to compete with other vendors will be allowed. (If we receive your application and already have **TWO** vendors with the same merchandise we will notify you.)
- Food vendors are **REQUIRED** to send a copy of proof of insurance.
- ➤ ALL vendor who pays in full will be guaranteed a spot before those who send only a deposit.
- > ALL VENDORS MUST PAY FOR RENTED AREA/AREAS IN FULL ONCE THEY ARRIVE AND HAVE CHECKED IN WITH MIDWAY DIRECTOR (Chuck Cassidy). YOU WILL NOT BE ALLOWED TO OPEN FOR BUSINESS UNTIL THEN.
- ➤ All deposits are **Nonrefundable** as of July 1, 2018.
